4. Matters arising

- Don Naylor (via Microsoft Teams chat) From 25/05/2023 notes, a correction: it's some Universities, not schools, that have banned oil & gas companies from recruitment fairs. But, with schools, are we assured that anyone presenting for HyNet is covering the challenges, e.g.: all the unknowns around CCS?
- (Answered in the minutes) The minutes of the previous meeting 25.05.2023 have been altered.
- Don Naylor (via Microsoft Teams chat) From 25/05/2023 meeting: did the term 'low carbon hydrogen' get revisited?
- (Answered in the minutes) The use of the term 'Low Carbon Hydrogen' was discussed with Martin Land, Project Director of Mersey Tidal, who advised that this term is used because it is consistent with wording used by the UK Hydrogen Strategy
- Don Naylor (via Microsoft Teams chat) From 25/05/2023 meeting: alongside the
 positives of local nature gain, should we recognise global nature loss? There are
 global to local interconnections, eg soya from deforested Brazilian Cerrado that is
 shipped in through Liverpool (for Cargill)
- (Answered in the minutes) This might be something we could address in the future but the LCRCA is currently focussed on immediate action opportunities in areas we can directly influence. This is not something that the LCRCA is currently considering

 - O Who else (that isn't in this meeting) needs to know about this?
 - Young climate leaders a bespoke programme for 1-2 young people from each borough

- Sarah Lovell Seeing if there are natural synergies with projects already happening
- Don Naylor Could bamboo be used to build greenhouses?
- Sarah Lovell Yes, already in conversation with Eden Project North in Morecambe
- Cllr Gill Wood There are a number of local structural engineering companies who
 would likely want to have some involvement. There is a youth conference being
 organised with the North West Net Zero Hub.

- Nick Thompson I would like to explore on behalf of the horticultural project managed by Emmaus Merseyside the possibility of growing bamboo on site and possibly building our next polytunnel out of bamboo who can I talk to?

6. Update on public sector buildings decarbonisation initiatives (Eddie Boyd and Luca Biagioni, North West Net Zero Hub)

- Eddie Boyd Shares slides
- Stressed the importance of collaboration

Questions:

- Don Naylor What are the funding models for district heat networks?
- Mike Wolffe Has the specification gone out for LCSF4?
- Luca Biagioni Hope to hear by tomorrow.
- Mike Wolffe Are LAs going to see sight of this before it goes public?
- Luca Biagioni Yes
- Mike Wolffe Is there a formal structure for the specification?
- Eddie Boyd Yes assistance will be given on this in a few forms. Looking to make options cost neutral for the LA involved.
- Nicky Crosby what opportunities are there to share this work with not-for-profit sector?
- Eddie Boyd Happy to share specifications and models intend to publish these.
- Annie Merry Working with the Diocese of Liverpool on decarbonising churches as well as places on the Wirral. Much can be learned by these places, so how can we access information that will help in achieving this?
- Eddie Boyd There is a benefit to sharing solutions through the North West Net Zero Hub through workshops or other mediums.

7. Buildings energy advisory initiatives (Peter Owen, Energy Projects Plus)

Peter Owen – Shares slides

Questions

- Nicky Crosby is most of the work you are doing with private home owners? Is it even worse with the private rent sector?
- Peter Owen Yes, the private rent sector is very challenging. There is a retrofit task and finish group on the Wirral, which is very keen to make sure landlords understand their role. A lot of it is down to affordability, including with the minimum EPC rating.
- Nick Thompson What is your business model? Do you charge people?
- Peter Owen No, we apply for grants, as we are a charity. Advice is free, for EPC certificates, they charge to cover the cost.
- Cllr Gill Wood Are you seeing a shifting demographic in people seeking help?
- Peter Owen Yes, a lot more people seeking financial assistance rather than measures for improvements.
- Cllr Gill Wood What are your thoughts on how goalposts being shifted on eco grants?
- Peter Owen In the past, schemes provided replacement boilers, but now they are looking to replace them with low carbon alternatives. Comes down to money and willingness to take on the cost. Hopes that the CA are able to make strides forward on helping to overcome these barriers.
- Tim Jago On behaviour change and making retrofit aspirational draws a parallel to EVs and the change in the past 5 years. If this comes from an aspirational standpoint

then this would be ideal, so maybe this will happen with the retrofit market. Retrofit in a house holds value much better than an EV.

- Nicky Crosby (via Microsoft Teams chat The CA has a role a) round the public awareness and behaviour change and b) round the training gap can it do more?
- (Answered in the minutes) Actions within the 5 Year Climate Action aim to address

 a) engagement, communication and behaviour change;
 b) work on green skills
 through the Green Jobs & Skills Plan through actions to ensure that development of
 green skills are at the heart of CA commissioning plans and to clear pathways to
 develop the green skills required
