






Local Nature Recovery Strategies (LNRS)

- A new statutory duty introduced in the Environment Act 2021
- Evidence based, locally-led, spatial strategies covering the whole of England
- Focused on nature recovery and reversing biodiversity decline
- Involve collaboration with local experts, LAs, Local Nature Partnership, wider stakeholders/industry and the public







Strategy Development

The Local Nature Recovery Strategy will:

Agree priorities for nature's recovery

Map the most valuable existing areas for nature

Map specific opportunities for creating or improving habitat for nature and wider environmental goals



March 2025 completion. Autumn 2024 draft.



2 years of funding for strategy development only



Collaboration with LAs, LNP, technical experts, wider stakeholders, neighbouring RAs with support of NE, FC & EA



Requires public consultation





Phase 1 map: most valuable existing areas for nature


Public engagement has begun













Current Focus: Public Engagement

First phase Oct 2023

- Light-touch **survey**: why nature is important to people and what they want to see from the LNRS
- Live as of 18th October
- Informs our biodiversity priority setting

Second phase Autumn 2024

- Consultation on draft strategy and opportunities map
- Sign-off by LAs
