























Complete Action Example



Action B4 - Deliver the decarbonisation plans for the first 50 public buildings to get ready to bid for Public Sector Decarbonisation Scheme funding.

- The North West Net Zero Hub has used £384,000 of Low Carbon Skills Fund money to assess 52 public buildings, to see what measures are needed to get them to net zero. This work forms the decarbonisation plans and informs the cost required to achieve net zero.
- With this data, a £34 million grant funding bid has been submitted to the Public Sector Decarbonisation Fund. The outcome will be known sometime in early 2024.
