I Welcome / Introductions/Actions

TB welcomed the group to the fourth LNRS technical meeting.

1) Species long list /shortlist- (update) - Andrew Clark / Jo Doolin- (MEAS)

- Longlist / shortlisting is in its final stages(as previously mentioned, the botanical and invertebrates lists have taken longer but working together with a sub group of the species technical group has enabled the further development of both lists-Jo to share with group once finalised.)
- Two habitat workshops have been held one in person and one online both went well, the notes and findings of the workshop are currently being written up, this will help form habitat assemblages etc – all of the workshop notes and findings will be on the LNRS LCR website. Panel members are still able to upload comments to the online whiteboard – Jo will circulate the link.
- One of the next steps is Priority setting which will be done in conjunction with the responsible authority, This will include looking at wider factors such as urgency of action / existing initiatives / deliverability -
- A matrix will be developed as part of the priority setting
 – so that each shortlisted species / assemblies can be weighted- the method of the development of this matrix is very important, and broad considerations are being taken into account the draft matrix will be circulated to the group.

2) Opportunity mapping update -

A final draft for review of the method statement has been issued to the responsible authority (LCRCA) for review which has been accepted. The responsible authority have commended the work of MEAS and LJMU on development of the methodology making note that many partners have been consulted in its development. LCRCA are currently working on a schedule of deliverables.

AC went through the final draft methodology (with a note that comments and tweaks are still welcome but wholesale changes can't be made at this point due to time restraints).

Timescales -

At the time of writing, LNRS timescales for completion of 'Develop local habitat (opportunities) map' task are by 23 August 2024. Development and mapping of measures is required by 28 June 2024. Additionally, a potential opportunity to identify up to 5 locations for National Highways and Network Rail green crossings has been

raised. A business case of species, habitats and what sites would benefit from interventions, including methods used to identify locations is required by 31 May 2024.

A question was asked by the panel how the LCRCA call for sites for the LNRS will fit with local authority call for sites (a recent example being Sefton BC put out a call to partners for habitat improvement sites).

This was answered – that an ongoing dialogue between the CA and local authorities with regards to this work and aligning the delivery of the LNRS with local plans will be an essential part of its successful implementation.

More broadly it was discussed that the call for sites will take a three tier approach - Landowners will be asked to submit potential opportunity gain sites, other stakeholders will be asked to submit current projects that are ongoing or planned that links could be made with and in addition the public will be asked to submit sites they have an interest in (for example action they would like to see there). The LNRS team will be working with their internal engagement team to use "Citizen space" which will enable all of the information to be gathered and utilised effectively.

3) LNRS Data Standards and Guidance Update - Tom Smart - Natural England.

TS provided a presentation which covered;

- Terminology (Must, Should, Could)
- Data must be shared in an editable format and sharable under Open Government Licence
- Data Standards Advice
- APIB's = Areas of particular Importance for Biodiversity.
- ACB'S = Areas that could become of particular importance.
- Mapping of Measures Guidance
- LHM Schematic
- Bridging National Infrastructure (call for green bridges)
